## PATIENT INSTRUCTIONS FOR LEXISCAN NUCLEAR STRESS TEST

- 1. Do **NOT** eat or drink anything but water for at least **4 hours** prior to your scheduled appointment time.
  - a. Bring a snack.
  - b. You may drink water at any time before your test.

- 2. NO caffeine/decaffeinated drugs, food or beverages for at least 24 hours before your test.
  - a. This includes but is not limited to any colas, coffees, teas, chocolates, Excedrine, Anacin, BC power, Butalbital.
- 3. Take your medication on your normal schedule unless told otherwise by your physician/nurse.
  - a. Bring a list of medications with you.
  - b. If you take any of the following medications, please call your physician/nurseto discontinue for 72 hours:
    - i. Aggrenox, Persantine (Dipyridamole), Aminophylline, Theophylline or Theophylline containing drugs (Theo-Dur, Constant -T, Primatene, Quibron, or Slo-Phylline).
  - c. **DIABETIC PATIENTS**: Do **NOT** take your diabetic medication on an empty stomach. If possible, please eat a small snack with your medication 4 hours prior to your appointment time. Otherwise, bring your medications with you along with a snack.
  - d. BRING ANY INHALERS WITH YOU.
- 4. Dress comfortably.
  - a. Please wear **SEPARATE** tops and bottoms. **NO** dresses, overalls or one-piece outfits.
  - b. Wear tennis shoes.
- 5. Please do not use body lotions and/or sprays or perfumes as this will affect EKG accuracy.
- 6. Be prepared to stay at least 3 hours.
- 7. You WILL be required to lie on your back with both arms above your head. If you CANNOT lie on your back or raise your **LEFT** arm, please notify your physician immediately for alternate testing.
- 8. A camera will rotate around your chest for 7-20 minutes. Your head and legs are **NOT** covered. If you are **CLAUSTROPHOBIC**, please notify your physician immediately to either view the camera or schedule alternate testing.
- 9. Your test will be read by a physician within 48 hours. Your results will be called or mailed to you by your ordering physician/nurse within 5-10 business days.
